- In the Regional Engineering College Duragapur some seats are reserved for the Scheduled tribes of Andaman & Nicobar Islands., every year. Before 1997 Ranchi tribal students were used to avail the unavailed reserved seats. But in 1997 this was banned. Two students Amit Alex Bara & Vinay Kishor Xalxo were called for the admission but they were rejected on the complain of local Born Association & the Administration of their not being notified tribal of Andaman & Nicobar Islands. It is noted that if the local tribals candidate are not available the non local tribal candidates can avail the seats. (The D.O. letter in Para 5 above may be referred).
- The Supreme Court order of 7 May 2002 was to remove the encroachers from the forest lands, in Andaman & Nicobar Islands. The similar order was issued to many other states of India but the state Governments & the ruling parties refused to implement the above said eviction order. The schedule Tribal people of Kerala opposed it violently. In police firing 14 people were killed. At last the Kerala government agreed to give five acres of land to each of encroacher tribal family in the forest land and approached the supreme court & central government for approval.

Here in Andaman 47% affected families are Ranchi Tribals. The Andaman Administration destroyed the agricultural crops such as coconut, arecanut, mango lemon orange etc. trees without discriminating the tribals.

In this connection the address of the President A.P.J. Abuul Kalam to the joint session of Parliament on 7-6-2004 may be referred VIDE PARA 29 wherein. He emphatically says " Eviction of tribal communities and other forest dwelling communities from forest area will be stopped (ANNEXURE (C)

Ranchi people are tribals of India. The tribals don't lose their identities with regards to central service. This also will be applicable for the matter which is concerned with central government. Eviction of forest land encroachment of Union territory is central concern Hence the eviction of Ranchi tribals must be stopped.

About migration, It is better to refer the BROCHURE on Reservation & concessions for S.C/ST/and O.B.C. Chapter [4] SC/ST certificate verification. 4.3 (2) SC/ST person on migration from the state of his own origin to another state will not lose his status as SC/ST. He will be entitled to the concession benefits admissible to the SC/ST person under central government ANNEXURE (D).
