Nobody from the Forest Department attended the meeting.

At the outset, the Director (TW) recalled the instructions issued vide this Secretary (TW)'s letter No. 1-546/2001-TW/620 dated 16<sup>th</sup> Aug., 2001 to all the sectoral departments following the interactive sessions between the Tribal leaders, Members of Zilla Parishad and Officers of the Administration held on 01<sup>st</sup> & 02<sup>nd</sup> August 2001 regarding formulation of the draft Tribal Sub-Plan for the 10<sup>th</sup> Five Year Plan (2002-2007) and Annual Plan (2002-2003). However, as informed by the departments the proposals were still being worked out by them. In the meanwhile, a list of works/schemes received from the Chairperson, Tribal Council, Nancowry and Chairperson Tribal Council, Car Nicobar were circulated to the various departments at the meeting, requesting them to consider those works / schemes under the Tribal Sub-Plan for the 10<sup>th</sup> Plan period, if feasible, which they agreed.

Further, they were requested to work out the proposals for 10<sup>th</sup> Five Year Plan and the Annual Plan and submit to the Directorate of Tribal Welfare latest by 29<sup>th</sup> August, 2001. It was reiterated that the norm of allotment of fund atleast proportionate to the tribal population, as hitherto followed may be adhered.
