

They were employed in the rubber project at Katchal and were allotted with half-an-acre of land for the purpose of Kitchen Garden. However, this land was allotted without any documents such as patta, as Katchal Island is Tribal Area. Thus the families have not been really rehabilitated in real sense. The Island being a Tribal Area there is always constraints for economic activities and growth. The meager daily Rated wage from the Rubber Project (now Forest Corporation) for tow working members in a family is not adequate for the growing size of the families. Even today the families are residing in the barracks allotted by the Rubber Project, which is hardly adequate for the grown up family size. There are other associated innumerable social problems for the youths also, in terms of good education employment opportunities etc.

Most of the family members have retired from the Rubber Project during this 28 period of stay. They neither have any alternate means of livelihood like agriculture etc. in the absence of any land available with them, nor any opportunity to seek employment in any private organizations. At this juncture, the solution may be may be as under: -

- Allotment of Cultivate land for each family as was allotted to other settlers settled in these Islands.
- The settlers may be shifted to other Non-Tribal Islands.

Point-13

Sanction of Risk / Hard Area allowance to the employees of A&N Administration working in Southern Group of Islands (i.e Nicobar District)

- (i) Entire Nicobar District except Campbell Bay is reserved area
