OF NANCOWRIE GROUP OF ISLANDS COVERS TWO TRIBAL COUNCILS UNDER HIS JURISDICTION NAMELY TRIBAL COUNCIL KAMORTA AND TRIBAL COUNCIL NANCOWRIE 1. THE ONLY LADY WHO IS CHAIRMAN/VICE CHAIRMAN IS SMTI.
