No. (19)/7/86-CA/1099 dated 31.1.1978 and as modified vide O.M. of even No. dated 16.9.78 under information to this Ministry and submit an expenditure statement to the Pay and Accounts Officer, Ministry of Tribal Affairs, Shastri Bhawan, New Delhi through SCT who will exhibit the amount in his appropriate accounts.
