**1) Case Crime No.822/2002 dated 17/08/2002 U/s451/354 IPC r.w.s.3(i)(xi) SC & ST POA Act 1989 of P.S. Aberdeen -**

On 17/08/02, one Raju S/o Muniyandi R/o Nayagaon entered in the room of Miss Lafa, a Jarawa girl who was admitted in special ward of G.B.Pant Hospital Port Blair and molested her by pressing her breasts. He was caught by the ward boy on duty. On this the above-referred case was registered and the accused was arrested on 17/08/02 after completion of the investigation the case was charge sheeted against accused Raju S/o Muniyandi vide CS No. 864/02 dated 02/09/02, which is subjudice in the Court of Law.

**2) Case Crime No. 1680/2003 dated 09/10/2003 U/s363/324 IPC r.w.s. 3(i)(xi) SC & ST POA Act 1989 of P.S. Aberdeen -**

On 09/10/03, statement of Kumari Ellaya D/o Rigi (12) R/o Strait Island was recorded in which she disclosed that she is studying in class VI th of Nirmala School and staying in the Hostel of the said School. On 08/10/03 around 1800hrs, while she was going from hostel to church, all of a sudden one Maruti Omni came there and 3-4 persons came out and put a handkerchief on her mouth and took her inside the Omni and sprayed some powder on her face. Consequently she became unconscious. Around 2000 hrs. on the same day she regained her senses and found herself abandoned near Water sports Complex Aberdeen Bazar Port Blair. From there she went to Adi Basera by walk. She narrated the facts to her mother and went to G.B Pant Hospital for treatment. Upon this the above referred case was registered and after completion of investigation, report in final form vide FR No.61/04 dated 26/11/04 as untraced has been submitted in the Court of Law.

**4) Case Crime No. 10/2004 dated 17/03/2004 U/s 354 IPC r.w.s. 3(xi) of SC & ST POA Act 1989 of P.S. Car Nicobar. -**

On 17/03/04 Doctor Harold Chalras, M.O, BJR Hospital C/Nicobar lodged a report that he sent her daughter Kumari Priyanka (9) yrs to buy some edibles from the shop of one Ramaswamy on 15/03/04. Finding the girl alone, the accused Ramaswamy caught hold of her hand and molested her. Upon this, the above referred case was registered and the accused was arrested on 22/03/04 after investigation, the case was charge sheeted against the said accused vide CS No. 13/04 dated 07/04/04, which is pending trail in the Court.
