

Copy of D.O letter No. U-17011/4/85-ANL dt nil from Shri Surendra Kumar, Deputy Secretary, Ministry of Home Affairs, New Delhi addressed to Shri R.D.Kapur, Chief Secretary, A & N Administration, Port Blair.

With a view to simplification of procedures and improvement in efficiency, review of various periodical reports and returns, prescribed by this Division for submission, has been undertaken. As a result, it is felt that the following two quarterly reports and returns need not be submitted separately:-

1. Quarterly report relating to defence and development.
2. Quarterly report of progress or work in respect of Andaman Trunk road and contacts with Jarwa tribel.

The second report should be merged into first one and one consolidated report in respect of defence and development works, including Andaman Trunk road, should be submitted on the existing pattern.

Another quarterly return has been laid down in respect of group (C) & (D) posts filled by appointment non-local persons in relaxation of instructions on the subject under this delegated power by the Lt. Governor. It has been decided that this return may be discontinued. It is, however, felt that the monitoring function performed by this report is important and needs to be continued. It has, therefore, been decided that whenever a non-local candidate is appointed to a group (C) & (D) post under the powers delegated to the Lt. Governor, a copy of the order granting relaxation should be endorsed to this Ministry. In case no non-local person has been appointed during a calendar year, a certificate may be furnished to this Ministry indicating the same. This certificate should be sent by 15th January in the year following the year to which it pertains.
