The proposal is for obtaining approval for carrying out the services of M/s Dream Destination, PB No. 410, Junglighat for providing of security guard for round the clock watch and ward duty of the newly Tribal Transits Hostel building constructed at Brookshabad from 3/2011 to 11/2011.

In this context, the following facts are submitted for kind perusal and approval please.

- 1) Under the regular Plan Scheme of this department, Tribal Transits Hostel building was constructed at Brookshabad for the benefits Nicobari tribals of Nancowry group of islands.
- 2) An inspection was made after its construction and it was assessed that the said building is easily accessible for any outsiders to enter inside the building.
- 3) Accordingly, it has been decided to engage and deploy security guards for watch and ward duty of the said duty and hence rates of the Social Welfare Department was obtained who has accepted the rate of M/s Dream Destination, PB No. 410, Junglighat after observing all codal formalities. Para 319/n to 326/n.
- 4) As per Para 322/n, the Security guard is to be appointed for three months or till the building is handover to the Tribal Council, Nancowry
- 5) Agreement was executed with the firm M/s Dream Destination for deployment of security guards Tribal Transits Hostel building from 26.2.2010
- 6) On 1.11.2011 (Page 135/c), the Chairperson, Tribal Council, Nancowry taken the possession of the Tribal Transits Hostel building constructed at Brookshabad.
- 7) The firm M/s Dream Destination vide letter 8.12.2011 has requested to settle the payment for the months from 3/2011 to 11/2011 on the basis of the revised rates of the Administration which came in existed from 1.7.2011. The details of the bill raised by the firm are as under: -
