

(103) This is regarding payment of the salary for the services of the security guard round the clock watch and ward duty in the Transit Tribal Hostel Building constructed at Brookshabad.

(104) The newly constructed building of Transit Tribal Hostel Building at Brookshabad was handed over to the Chairperson Tribal Council, Nancowrie on 1.11.2011. We had requested the Chairperson Tribal Council, Nancowrie to make the payment of the salary for the services of the security guard round the clock watch and ward duty in the Transit Tribal Hostel Building constructed at Brookshabad from Dec'2011 onwards vide letter dated 31.8.2012 at flag 'A'. The Chairperson Tribal Council Nancowrie vide letter dated 9.10.2012 at flag 'B' has stated that the Transit Tribal Hostel Bldg at Brookshabad was takenover but could not generate any fund till date. Due to paucity of fund the payment of salary of the security guard deployed in the Transit Tribal Hostel could not be made. She has requested to release fund under the development activities of the Tribal Council, Nancowrie so that the payment of the salary of the security guards could be made and also requested to discontinue the services of Security Guard as one of the representative of the Tribal Council is taking care of the Transit Tribal Hostel. Accordingly, M/s Dream Destination, Junglighat was requested to discontinue the services of the security guard wef 15.10.2012 and was also requested to submit the bills towards the payment of salary of the security guards from Dec'2011 to 14.10.2012 vide letter dated 15.10.2012 at flag 'C'. M/s Dream Destination, Junglighat has discontinued the services of the security guard wef 15.10.2012 and submitted the salary bills of the security guard from Dec'2011 to 14.10.2012 to this office for making payment.

(105) Necessary approval of the then Secretary (TW) for engaging the security guards for the watch and ward duty of the newly constructed Transit Tribal Hostel may kindly be seen at flag 'X'.

(106) It is therefore proposed that the payment of the security guards from Dec'2011 to 14.10.2012 could be made out of the fund under Major Head 2225 OE (Plan) instead of releasing fund to the Tribal Council, Nancowrie for making payment. The rate of wages of security guard claimed in the bills is as per the notification of Administration. The details of the bills are as under:
