I am to refer to letter dated 04.10.2007 (copy enclosed) on the above subject from my predecessor and reminder letter dated 16.01.2008 and to say that the requisite information on six points in respect of your State, that was sought to be furnished by 28.01.2008 is still awaited. Since the information sought by the Commission relate to existing instructions on the subject, several other States have furnished the requisite information. You will appreciate that it would not be desirable if the Commission fails to fulfill its constitutional responsibility to report on the ground reality on the subject prevailing in your State. I would, therefore, request you to issue necessary instructions to the concerned Nodal Department in your State to ensure that the requisite material alongwith copies of supporting documents, orders, Acts, and instructions etc. are positively forwarded to the Commission by 30.04.2008.
