Sub: - Deprival and denial fundamental rights-reg.

Her Excellency,

I am to submit as follows:

That, there is a voice amongst the permanent residents of these Islands brought under panel settlement scheme by the Britishers with the view to retain 572 Islands of Andaman & Nicobar Islands within the map of India so that other countries like China, Burma do not get inspired with the temptation to occupy taking undue advantage of the situation.
