Subject :- Complaint for discrimination on the ground of Caste, Place of Birth, Residence etc. in the matter of Public Employment for the Post of Surveyor against reserved quota for Scheduled Tribes candidate in the Office of the Deputy Commissioner, South Andaman District under the Union Territory of A & N Administration. - Regarding.

Respected Sir,

I, Smti. Chitta Kumari, Wife of Shri. Madan Kerkta, Resident of Bird Line, Kalicut Post Office, Prathrapur Village of Port Blair Tehasil of South Andaman District do hereby state to your goodself that I was applied for the Post of Surveyor against Scheduled Tribes quota in the response of Deputy Commissioner's Office Advertisement Published in the Daily Telegrams on 22nd March, 2006 but the Deputy Commissioner Office was not considered my application on the ground of my Caste "Munda" is specified as Scheduled Tribes in the relation with the State of Bihar (Now in Jharkhand) under the Constitution (Scheduled Tribes) Order, 1950 and my Caste "Munda" is not specified as Scheduled Tribes in relation with the Union Territory of A & N Islands under the Constitution (Andaman & Nicobar Islands Scheduled Tribes) Order, 1959.

But, other side your Administration is extended reservation benefits for Scheduled Tribes to Four Persons of other States in APWD namely (1) Shri. S. Tej Bahadur, Executive Engineer (Civil) is belongs to "Lambadis" Caste of Andhra Pradesh State (2) Shri. H. M. Lingaraju, Assistant Engineer (Civil) is belongs to "Nayaka" Caste of Karnataka State (3) Shri. Krishna Kumar, Assistant Engineer (Civil) is belongs to "Kondareddis" Caste of Tamil Nadu State (4) Shri. D. Ravana Siddappa, Assistant Engineer (Civil) is belongs to "Nayaka" Caste of Karnataka State, although their Caste namely Lambadis, Kondareddis, and Nayaka is not specified as Scheduled Tribes in relation with the Union Territory of A & N Islands under the Constitution (A & N Islands Scheduled Tribes) Order, 1959 but Administration is extended reservation benefits for Scheduled Tribes to them in A & N Administration. They were initially recruited from Mainland as Junior Engineer (Civil) in APWD under the A & N Administration and subsequently their Promotion were granted from the feeder cadre posts to higher cadre Promotional Posts against ST quota in APWD by Andaman & Nicobar Administration.

In these circumstances, I am discriminating on the ground of my Caste, Place of Birth, and Residence etc. which is opposed to Article 14, Article 15 (1) and Article 16 (1) (2) of the Constitution of India.
