Sir,

To ensure that no pseudo Scheduled Caste/ Scheduled Tribe claimants can grab the facilities and only genuine candidates avail the benefits, and as per the directions and guidelines issued by the Hon'ble Supreme Court in Special Leave Petition No.14767/93 [in the case of Madhuri Patil V/s Additional Commissioner, Tribal Development, Thane and others] the Government of Maharashtra has passed an enactment namely "Maharashtra Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes, Other Backward Classes and Special Backward Category (Regulation of Issuance and Verification of) Caste Certificate Act, 2000".

Further, considering the fact that the peculiar procedure is required to be followed by the Scrutiny Committee for verification of Scheduled Tribe Certificates, the State Government has made separate Rules called the "Maharashtra Scheduled Tribes (Regulation of Issuance and Verification of) Certificate Rules, 2003."

Presently eight Scrutiny Committees are working in the State of Maharashtra for verification of Scheduled Tribe certificates, issued by the Competent Authorities. Similarly, the committees are also in place for verification of Scheduled Castes, Scheduled Castes, Scheduled Tribes, De-notified Tribes
