Sub: Implementation of the Recommendations of the First Report of the National Commission for Schedule Tribes (NCST) for the years 2004-05 and 2005-06- regarding.

Sir/Madam,

The National Commission for Scheduled Tribes (NCST) has been constituted under Article 338 A of the Constitution on 19.02.2004. The Commission has submitted its 1st Report for the years 2004-05 and 2005-06. A copies of the Summary of Recommendations of the Commission, relevant to the State Govts./ UT Admsn., were sent under this Ministry's D.O letter of even number dtd 3.04.2007, addressed to the Chief Secretaries and Secretaries to Governors of States.

2. As per provisions contained in Section 7 of Article 338 A of the Constitution, the Report relating to the State Government shall be forwarded to the Governor of the State who shall cause the Report to be laid before the Legislature, along with a memorandum explaining the Action Taken or proposed to be taken on the Recommendations, with reasons for non acceptance, if any. Accordingly, copies of the 1st Report (bilingual) were sent to the Secretaries to Governors of States under D.O. letter of even number dated 14.10.2011, with the request to have appropriate action taken on each of the recommendations relating to the States and also keep this Ministry informed of the position.

3. The Commission has recommended (at serial Nos. 9 of Chapter-7 under heading "Issurance and Verification of Scheduled Tribe Certificates") in the First Report as extracted below:-
