PUC is decision No.CIC/SG/A/2011/002292/15898 appeal No.CIC/SG/A/2011/002292 dated 24/11/2011 from the Information Commissioner, Central Information Commission, Club Building (Near Post Office), Old JNU Campus, New Delhi 110067 communicating the decision on appeal made by Smti. Chitta Kumari, W/o Madan Kerketta made under RTI Act 2005. Central Information Commission has allowed the appeal with the direction to the PIO of Directorate of tribal Welfare Department to provide information on query-3 to the appellant before 20/12/2011.
