Reply: Yes. Usually the isolated individual posts and small cadres are being grouped with posts in the same class for purpose of reservations orders taking into account the status. The Directorate of Tribal Welfare being Nodal Agency is approving the grouping of posts.

Reply: No such case has been pointed out till date. Being co-opted member, usually the ST Representative agreed with the other members of the selection committee/ DPC and puts their signature in the proceedings.

Reply: Yes. All the posts which are being notified clearly indicate the number of posts reserved for ST in the advertisement. In A&N Islands, there is no are Association and Organization of Scheduled Tribes is exists.
