Dear Shri Kutty,

Kindly refer to this Ministry's letter of even number dated 26<sup>th</sup> December, 2001 and subsequent reminders dated 6<sup>th</sup> February, 2002, 7<sup>th</sup> March, 2002, 27<sup>th</sup> March, 2002 and 10<sup>th</sup> April, 2002 regarding material for the Annual Report on the measures taken by the State Governments / UT Administrations during the calendar year ended 31<sup>st</sup> December, 2001. The information is required for laying the Annual Report on the implementation of the Protection of Civil Rights Act, 1955 in the Parliament.

2. The information is required to be furnished in two parts: **Part- I** relates to summary of measures taken by various State Governments/Union Territory Administrations for implementation of the provisions contained in Section 15(A) (2) of the Protection of Civil Rights Act, 1955 viz. Legal aid, appointment of officers, committees, special courts, periodical surveys, identification of untouchability prone areas and other measures taken for the removal of untouchability and **Part - II** relates to statistical details of cases registered with Police and in Court under the Protection of Civil Rights Act, 1955 and their disposal during the calendar year reported upon and **Part - III** relates to statistical details of the expenditure incurred under this Act, during the calendar year reported upon.

3. I would request you for giving your personal attention and sending statistical data along with detailed write up related to the Act for the calendar year 2001, latest by 20<sup>th</sup> May, 2002, so that the report can be prepared and laid in Parliament well in time.
