The subject matter is regarding implementation of A&N Islands (Tribal Council) Regulation, 2009.

It is submitted that from last 2012 onwards, the Election Commissioner is pressing hard for finalization of Draft Electoral Rules of Tribal Councils. To implement the Regulation, a draft of the Rules titled "Andaman and Nicobar Islands (Tribal Councils) (Preparation of Electoral Rolls and Conduct of Elections)" Rules, 2011 was prepared and sent to the Deputy Commissioner (Nicobar District) for wider consultation with the tribal leaders on time to time basis. But due to the reservation of the tribal councils, the same could not be implemented till date.

Pursuant to the DO letter dated 25.1.2016 of the Election Commission for UT, this Directorate had convened a meeting with the office bearers of Tribal Council of Teressa, Chowra, Great & Little Andaman, Kamorta and Nancowry on 8.2.2016. Copy of the minutes of the meeting dated 8.2.2016 may be seen at Page 173/c.

In the meantime, this Directorate had also requested the Dy Commissioner, Car Nicobar to obtain the views of the remaining tribal councils. Now, we have received the views of 06 Tribal Councils except Tribal Council, Chowra, which is submitted as under:
