acquainted with the Draft Electoral Rules devolution of powers & election pattern proposed under the rules, functioning of the Local Self-Governing Institutions and their effectiveness consequent benefits which will be gained by the tribals in terms of social and economic development of the tribal community

(i) Car Nicobar, (including Harminder Bay village situated at Little Andaman) (ii) Nancowry, (iii) Kamorta, (iv) Katchal, (v) Teresa, (vi) Chowra and (vii) Great & Little Nicobar have expressed their willingness and have furnished their No Objection Certificates for implementing the Andaman and Nicobar Islands (Tribal Councils) Regulation, 2009 which may kindly be seen at flag 'A', 'B', 'C', 'D', 'E', 'F' & 'G' which is submitted as under:
