Subject: Visit of Election Commissioner and other officers to Andaman & Nicobar Islands in connection with forth-Coming Panchayat & Municipal Elections.

Dear Shri Rec,

Apropos our telephonic conversation on the above subject yesterday, I propose to visit Andamans' from 28.06.2010 to 02.07.2010. I will be accompanied by Secretary to Election Commission (UTs'), Sh. M.M. Sharma, and my PS Sh. R.M. Bisht. During this visit we will be attending to the draw of lots for reservation of seats for women in the Municipal & Panchayat Elections for both the districts of Andamans. Besides, we would also like to discuss other pending administrative matters and issues pertaining to operationalising the Andaman & Nicobar Island Tribal Council Regulation 2009 notified by the Govt. of India on 31.12.2009.

As discussed, I would like a meeting with you and all concerned officers on 29.06.2010 (Tuesday) at any time convenient to you in the afternoon. It will be useful if Finance Secretary, Panchayat Secretary, Director Municipal & Panchayat Elections, Director RD / PRIs / ULB apart from the concerned two Dy. Commissioners of North & Middle Andamans, Sh. Ashish More, & South Andamans, Sh. S.N. Jha, could attend this meeting. On Wednesday, i.e. 30.06.2010 in the forenoon I would like to complete the work pertaining to draw of lots for reservation of seats for women in the Port Blair Municipal Council and in the afternoon we could do the same for the Panchayat Elections in South Andamans District. On 01.07.2010, I along with my team of 02 officials would like to fly out to Mayabunder for undertaking draw of lots for reservation of seats for women in respect of North & Middle Andamans District, and, also discuss other elections related issues. We would like to return to Port Blair on the 02.07.2010, and have a final wrapup session with you & your officers sometimes in the afternoon. It would also be helpful if you could invite the DC Nicobar Island to attend the meeting on 02.07.2010, so that we would review the progress regarding the enforcement of provisions of the notification No. 11023/2/2006-UTL dated 31.01.2009. In this regard Secretary to Election Commission (UTs') has already sent a letter to Nicobar Island on 02.06.2010 (copy enclosed).
