**Sub: Operationalisation of the A & N Islands (Tribal Council) Regulation, 2009-
Proposal for providing administrative support mechanism to Island and
Village Councils-Submission of**

As you are aware, the A & N Islands (Tribal Council) Regulation 2009 has come into force with the publication of the same by the Ministry of Law and justice (Legislative Department) GOI, New Delhi in the Gazette of India vide Notification No. 56 dated 31.12.2009. In order to operationalise the said regulation, for meeting the aspirations of the Tribal Community by providing them with greater autonomy, as per the directions of the GOI, Election Commission and the UT Administration, the District Administration has drawn-up a tentative schedule for various activities according to which the process of constitution of Local Bodies viz Village Councils and Island Council would be completed by 31.1.2011.

In order to make these local bodies functional, it is imperative that the minimum required administrative support mechanism to these local bodies are positioned well in advance in accordance with Section 23 and 66 of the A & N Islands (Tribal Council) Regulation 2009.

Keeping this objective in view, a comprehensive proposal to provide the administrative support mechanism to these local bodies to discharge its administrative, accounting, budgeting, planning, engineering and other technical functions has been prepared and is submitted herewith. It is stated that the administrative support mechanism proposed at various levels are the barest minimum requirement and are absolutely essential to make the system functional.

Necessary action may be taken on 'TOP PRIORITY' to get these posts created so that necessary action could be taken to position various functionaries well in advance so that the time frame drawn up for constitution of the local bodies could be adhered to.

FOR THE TIME-BOUND IMPLEMENTATION OF TRIBAL COUNCIL REGULATION AS ENVISAGED IN THE ATTACHED ROAD-MAP, A DEDICTED CELL WITH THE REQUISITE STAFF MAY BE POSTED TO OFFICE OF THE DEPUTY COMMISSIONER, CAR NICOBAR ON URGENT & TEMPORARY BASIS.
