## NOTE

Implementation of the Andaman and Nicobar Islands (Tribal Councils) Regulation, Sub: 2009- Revised Tentative Time-frame thereof:

Kindly recall the discussions held on this matter in the meeting held on 2<sup>nd</sup> July 2010, under the chairmanship of the Chief Secretary (i/c), wherein the Election Commissioner (UT) was also present. As pointed out by the Election Commissioner (UT), the Commission shall be pre-occupied with election activities in various other Union Territories till April 2011 and as such would not be in a position to conduct elections to Village Councils and Island Councils in Nicobars District in December/January 2010/11 as proposed earlier. It was stated that conditions remaining the same, the Commission would be conducting the elections in April 2011.

There are various factors having a bearing on conduct of elections in these islands. The scope of conducting elections, other than in the month of April, is limited due to the following reasons:

(a) The board examinations are being held in the month of March and the teachers, required for conduct of elections as polling-personnel, shall be pre-occupied.

(b) The two-month school-vacations start from 1st May onwards and the teachers shall be out of station/on leave.

(c) From July till early September is monsoon season and it shall be very difficult to manage the logistics required for smooth conduct of elections.

If the opportunity of conducting elections in April 2011 is lost, then it may be held only in the month of September 2011.

The tentative time-frame proposed earlier is revised accordingly and re-submitted as under:
