

101. (1) Notwithstanding anything contained in this Regulation, the Bar validity of any law relating to delimitation of constituencies or allotment of interference by courts in election seats to such constituencies made or purporting to be made under this matters. Regulation shall not be called in question in any court.

- (2) Save as otherwise provided in sections 96, 97, 98, 99 and 100, no civil court shall have jurisdiction to question the legality or validity of any action taken or decision given by the Election Commission or the Secretary, Tribal Welfare or the Deputy Commissioner in connection with the conduct of elections under this Regulation.
- 102. The Deputy Commissioner or Assistant Commissioner may in the Power to enter. case of Village Council and Island Council, authorize any of his officers to enter in and inspect or cause to be entered and inspected any immovable property occupied by any Village Council or Island Council or any work in progress under the direction of such Village Council or Island Council, as the case may be.

103. (1) No action shall lie against any member, officer, employee or Bar agent of a Village Council or an Island Council acting under the direction of against council, such Village Council or Island Council in respect of anything done in good etc. and previous such Village Council or Island Council in respect of anything done in good notice faith under this Regulation or any rule or bye-law made thereunder.

- (2) No action shall be brought against any Village Council or an Island Council or a First Captain or Second Captain or Chief Captain or Vice-Chief Captain or any of their members, officers, employees or agents for anything done or purporting to be done under this Regulation and the rules framed thereunder, until the expiry of two months next after notice in writing has been left or delivered at the office of such Village Council or Island Council and also at the residence of such of their members, officers, employees or agents against whom action is intended to be brought and such notice shall state the cause of action, the nature of the relief sought, the amount of compensation, if any, claimed and the name and place of residence of the person who intends to bring the action.
- (3) Every such action shall be commenced within six months after the accrual of the cause of action and not afterwards.
- 104. Every member of the Village Council or an Island Council and Members, etc. of every officer and employees maintained by or employed under a Village Councils to be public servant. Council or an Island Council shall be deemed to be a public servant within 45 of 1860. the meaning of section 21 of the Indian Penal Code.

105. No member of a Village Council or an Island Council or any of their Members, etc. to officers or employees having any duty to perform in connection with any part at sale. sale under this Regulation, shall directly or indirectly bid for, or acquire any interest in any property sold at such sale.

106. Every police officer shall give immediate information to the Village Power and duties 106. Every police officer snall give immediate information to the village of police and Island Council of an offence coming to his knowledge which respect has been committed against this Regulation or any rules made thereunder offences and shall assist all members and employees of the Village Council and assistance Island Council in the exercise of their lawful authority.

107. Every Village Council and Island Council shall classify and Classification and preserve its records in the manner prescribed.

108. Every Village Council and Island Council shall, on an application Inspection made to it by any person interested, allow inspection of its records and grant copies of records. certified copies thereof on payment of the prescribed fee.

109. (1) If any difficulty arises in giving effect to the provisions of this Removal Regulation, the Administrator may, by order published in the Official Gazette difficulties. make such provisions not inconsistent with the provisions of this Regulation as appear to him to be necessary or expedient for removing of that difficulty:
