Sub:- Exemption from convoy system at ATR for traveling to Port Blair from Mayabunder - reg:

Sir,

With due respect, I would like to submit that I am performing the responsibility of Adhyaksha of Zilla Parishad, North & Middle Andaman. Both North Andaman Sub-Division and Middle Andaman Sub-divisions are represented by me. I have to travel very frequently to Port Blair for Official purpose as well as public welfare works. During most of the instances I don't have enough prior intimation, so that I could manage my trips systematically according to the convoy timings of the ATR through Jarawa reserve area. In this aspect, consequently a lot of time is being usually wasted in waiting for convoy timings.

Recently, during the visit to attend the meeting with Hon'ble Home Secretary, Govt. of India, I suffered a lot because of that convoy system. I had to stay for two and a half hour at Jirkatang for the next convoy. In the meanwhile; the Deputy Commissioner, North & Middle Andaman who was allowed beyond the convoy system. When enquired by my staff, it was told that the Deputy Commissioner has been exempted from the convoy system. Hence, it was great matter of sorrow that having more responsibility in the District, still I was not allowed. So, I feel that it is quite embarrassing for a top representative of the District in PRI system is not allowed and others are exempted.

It is, therefore, requested that I may kindly be exempted from convoy time system at ATR through Jarawa reserve areas to and fro in between Mayabunder to Port Blair. It will enable me to fulfill the needs of PRIs, general public and other official and welfare works of North & Middle Andaman.
