28	This is a letter from the Assistant Secretary (Home) addressed to Director General of Police and Director (TW) forwarding extract of point of No. 3 (d) of the daily summary information dated 14/10/2013 with the request to furnish a detail report on the matter to A&N Administration.
29	Point No: 3 (d) reads as follows:-
30	"Information has been received that on 12/10/2013, in the morning 0600 hrs ATR convoy from Jirkatang to Middle Strait, Mr. B.P. Ray, M.P along with PSO, who was proceeding to N&M Andaman to inspect the affected areas of water logging, stopped his vehicle on ATR at 9 KM (Choudhary Gumai) and interacted with the Jarawa tribe. On this, the AAJVS staff who was present there try to restrict Mr B.P. Ray, MP to approach the Jarawa, but despite the caution of AAJVS staff, Mr. Ray interacted with the Jarawa tribe".
31	The incident took place on 12/10/2013 during the 1 <sup>st</sup> convoy from Jirkatang to Middle Strait. Shri. Raj Kumar Kongari, Janjati Sevak was the staff of AAJVS on duty near the Jarawa camp. Shri. Rajkumar Kongari, Janjati Sevak has submitted a statement on the incident, which is placed at page 42-43/C for kind perusal please.
32	As per his statement, he left Jirkatang at 0540 AM after making necessary entry in the Police dairy and reached his place of duty at 9 Kilometer on the ATR. While the 1 <sup>st</sup> convoy was on its way to Middle Strait, one vehicle stopped near the Jarawa camp and a person (PSO) came towards him and said that the MP is calling him. He went to the Hon'ble MP and requested not to stop here like this, but Hon'ble MP did not listen to his word.
33	He (AAJVS Staff) instructed the Jarawas in Jarawa language not to come out from the hut, but the Hon'ble MP went to the Jarawa huts and asked them what do you eat, and what you have eaten. They replied wild boar. The Hon'ble MP again asked what do you want, but they did not reply. The last vehicle of the convoy i.e. escort vehicle with green flag was waiting on the road. Thereafter, the Hon'ble MP and his PSO boarded there vehicle and left for Middle Strait.
34	Later, Shri. Kartikeyan, Assistant Sub-Inspector of Police, Jirkatang had sent his subordinate to his duty place and asked him to come to Jirkatang for details, he went to Jirkatang and lodged his statement on the incident. After a while, the Dy. SP came from Bambooflat and asked him, was he on the duty at that place; he read his statement on the incident and said nothing.
35	Apropos to the above, it is proposed that we may forward a copy of this note and statement of Shri. Raj Kumar Kongari to the Director (TW) for further action please.
