Sub:- Request for the extension of Convey time in evening upto 8.30 P.M. instead of 6.00 P.M.-reg;  
Sir,

With due respect I Shri V. Senthil Kumar, a Social worker on behalf of the Residents of Middle Andaman, beg to submit the following few lines for favour of your kind consideration and favourable action please:-

1. Sir, as you are well aware that the last convey from Yerataljig camp-03 and Prolobjig No. 15 is 6.00 P.M. but sometimes due to boat facilities to Nilambur in the Middle Strait and Gandhighat to Uttara the vehicles transported by small boat and resulted which the vehicle reaches to Yerataljig Camp No. 3 after 6.00P.M. The Private vehicles are sometimes to go to Mayabunder and Diglipur even but due to non-allowing the vehicle to go inside Jarwa Reserved area the passengers become helpless there because there is no lodging and Hotel Meals etc. They are having no other way to stay in vehicle without food and shelter.
2. Similarly the people from Baratang, Kadamtala, Shantanu and Uttara go to attend courts, Deputy Commissioner Office, A.R.C.S. and Zilla Parishad Office at Mayabunder and for other Offices at Rangat and due to some reasons or other if the buses are delayed from Mayabunder to Rangat before the last Bus at 4.30 P.M. from Rangat to Uttara Jetty then the people are forced to stay at Rangat either in Lodges if somebody shows petty on him and allows him/ her to stay at night.

For the above said reasons it is earnest requested to take necessary action to issue necessary instruction to the check post at Yerataljig Camp No. 03 Kadamtala and Prolobjig Camp No. 15 respectively to allow the vehicles to go through Jarwa Reserved area after 6.00 P.M. to 8.00 P.M. if the delay occurs due to delay in Convey System of boats or delay in reaching the last Bus from Mayabunder due to aforesaid reasons.

Therefore, you are humbly requested to take necessary action for the extension of existing last convey time from Prolobjig camp 15 to Rangat and Yerataljig Camp No. 03 to Rangat by 2 hours upto 8.00 P.M. at an early date. An early and favourable action in the matter is highly solicited.
