much expensive and it is out of reach of common man. We request you to consider the collection of sea sand from the concerned local areas as soon as possible.

- 5. Imposed of intolerable decision: The Andaman & Nicobar Administration has also amended the Protection of Aboriginal Tribes, Regulation, 1956 permit the vehicle to enter on ATR in emergency cases like, Ambulance, Mortuary vans and essential commodities. But it is regretted to say that there is no any provision to enter any death cases of blood relation those who are serving in different departments and working in private sectors at N & M Andaman/South Andaman after post convoy at Middle Strait and Jirkatang and the permission is to be taken from the Secretary (T/W) and DGP. In this connection it is strongly request to kindly issue necessary direction to the concerned officials to consider the above said matter by notifying for the beneficiaries.
- 6. <u>Re-operation of Tagore quarry</u>: The existing Tagore quarry had been in operation but unfortunately it was stopped by the Hon'ble Supreme Court in the matter of T.N. Godavarman Thirumalpad versus Union of India in a writ petition (Civil) No. 202 of 1995. Hence it is suggest that kindly issue necessary direction to the concerned authorities to submit a Dereservation proposal immediately.
- 7. De-reservation of 161.765 ha. of Forest land: I am to refer to the A & N Administration's letter number CF/FCA/102/Vol.II/253 dated 18.11.2010 on the above subject seeking prior approval of the Central Government under the Forest (Conservation) Act, 1980 and it is say that the Forest Advisory Committee (FAC) was agreed in-principal diversion provided that the revenue land under the possession of Forest land for regularization of pre 1980 allotment/encroachment. The A & N Administration has already given the require land an approximately 328 ha. to the Baratang Forest Division for aforestation purpose. The A & N Administration is needed to file an affidavit to obtain the permission of Hon'ble Supreme Court for de-reservation of forest land for regularization of allotment/encroachment on forest land. So kindly issue a suitable direction to the concerned authorities for an immediate redressal.
- 8. <u>De-reservation of Khatta Khari village</u>: Since the settlement of Khatta Khari village in Nilambur is still not notified and the settlement had been done in the year of 1959-62. As a result the villagers are facing a lot of difficulties. Therefore, it is requested to take an immediate action to avoid unnecessary harassments of the villagers of Khatta Khari.
- 9. Providing of Burial Grounds/Graveyards: There is no proper burial ground/graveyard for the Hindu/Muslim and Christian communities to their last rite in Baratang Island. The Hindu community is facing a huge difficulty to criminate the dead body as per Hindu customs since settlement of Baratang Island. Hence, kindly direct the
