The transportation of dead body along with close relative/kith & kin of the deceased shall be allowed in Hearse/Mortuary Van/ Private vehicle beyond convoy timings under proper police escort after making entry at the Police Check Gates at the respective entry points and it shall be the duty of the In-charge, Jarawa Protection Post of A&N Police at the respective entry points to keep a record of such cases allowed every month.

The rescue/ recovery of vehicle in the event of its breakdown on ATR within Jarawa Tribal Reserve shall be allowed beyond convoy timings after making entry at the Police Check Gates each time at the respective entry points under proper police escort. The Incharge, Jarawa Protection Post of A & N Police at the respective entry points shall, however, keep a record of the time taken for rescue and recovery of breakdown vehicle from Jarawa Tribal Reserve.

The Dy. Commissioner, South Andaman and North and Middle Andaman shall be allowed access through ATR beyond convoy timings only under emergency like law & order, natural calamities, after making entry at the Police Check Gates at the respective entry points.

The officers of the Department of Tribal Welfare including AAJVS, ANTRI and officers of the Department of Forest shall be allowed access through ATR beyond convoy timings on official duty only after making proper entry at the Police check gates at the respective entry points.


The Superintendent of Police, South and North & Middle Andaman Districts shall ensure that a convoy-wise monthly statement of the traffic moving through the portion of ATR passing through Jarawa Tribal Reserve between Jirkatang and Middle Strait is submitted to Secretary (Tribal Welfare) in the proforma appended to this Circular at **Annexure** by 10<sup>th</sup> of the following month positively.
