## CIRCULAR

Pursuant to the directions contained in its order dated 5.3.2013 of the Hon'ble Supreme Court of India in SLP No. 12125/2010 and the provisions made in the Andaman and Nicobar (Protection of Aboriginal Tribes) Regulations, 1956 (as amended), the Policy on Jarawa Tribe of Andaman Islands 2004, the Addendum to the Jarawa Policy of 2016, the vehicular traffic in the portion of Andaman Trunk Road passing through the Jarawa Tribal Reserve between Jirkatang-II to Middle Strait in South Andaman Island is regulated by the Administration through convoy system for protection of the aboriginal Jarawa tribe inhabiting these Islands.

The Administration, considering the difficulties being faced by the inhabitants using the Andaman Trunk Road including the suggestions received from various Departments, had made certain modifications in the larger interests of general public and Jarawas tribes.

However, in order to consolidate Circulars/Orders/ Memoranda/Addenda issued from time to time, the Competent Authority in the Administration has now decided to issue a comprehensive circular for regulating the traffic on ATR passing through Jarawa Tribal Reserve in supersession of all such instructions issued in the past, as under: -

- The vehicular traffic of LMVs and HMVs (both Govt & Private) except heavy vehicle carrying cargo and fuel, shall only be allowed in a convoy system with police escort on ATR passing through the Jarawa Tribal Reserve in South Andaman and Middle Andaman
- 2) There shall be four such convoys on portion LMVs and HMVs (both Govt & Private) except heavy vehicle carrying cargo and fuel on portion of ATR between Jirkatang to Middle Strait and vice versa with police escort as per the following timings: -

3) The heavy vehicles carrying cargo and fuel between Port Blair and Middle/ North Andaman shall move in one exclusive convoy on portion of ATR between Jirkatang to Middle Strait and vice versa with police escort as per the following timings: -

4) The two-wheelers and three-wheelers shall not be permitted to move on portions of ATR passing through Jarawa Tribal Reserve for ensuring protection of the Jarawas. Only Light Vehicles, Trucks and Buses shall be permitted.

5) The convoy passing through the Jarawa Tribal Reserve shall maintain a speed limit of 40km per hour ensuring that the vehicle do not stop and overtake during the entire stretch of journey within the Reserve.
