

Shri.Raman, R/o Humfrygunj turned up nor any reply received. However, on 21.1.2010 Shri.Thaiman stated vide his application that he has removed the conductor on coming to know the incident. He has therefore requested not to take any further action in this regard.

The vehicle was however sold to one Smti.Subhasini Mondal, W/o Mukunda Mondal, R/o Wandoor but the formal transfer of permit of the bus could not be effected until February, 2010 due to one or other reason, though Shri.Thaiman had applied for transfer of permit in favour of Smti.Subhasini Mondal vide his application dated 12.1.2007. Therefore it is evident that the said vehicle was under the custody of Smti.Subhasini Mondal on the date of the incident and complaint.

State Transport Authority has therefore taken serious note of the incidents and violation of permit conditions and decided that the permits issued to the above two buses may be suspended for a period of 6 (six) months.
