

**Minutes of the State Transport Authority meeting held in the Chamber of Secretary (Tpt.)/ Chairman, STA (in the Directorate of Transport) on 14.9.2010.**

At the outset the Chairman, STA welcomed all those present in the meeting.

The following decisions were taken on the agenda points which came up for discussion:

1. In the matters of having meeting with ACCI, Grain Dealers' Association, Vegetable Vendors Association before issue of Notification regarding fixing of time for loading and unloading of goods from 2100 hrs to 0700 hrs. in Aberdeen Bazar area instead of day time; and notifying of 'No Parking Zone' in front of R.K.Bar & Restaurant at Ranchi Basti, it was decided that Deputy Commissioner (S.A) may take appropriate decisions after hearing all those concerned.

It was decided that copy of charge sheets issued to Lord Balaji Bus bearing Regn.No.AN 01 A 4073 in connection with the fatal accidents occurred may be put up in the next meeting to take decision as to the kind of action to be taken on the report furnished by Dy. S. P (South Andaman). Superintendent of Police (S.A) may provide copies of Charge Sheets to Secretary, STA.

As regards implementation of installation of electronic fare meters replacing mechanical fare meters in autorikshaws, it was decided that information may be obtained from some States in mainland where it has been implemented and further, views of the Civil Supplies Department and Autorikshaw Union may also be obtained.

4. On the application received from Shri.Chittu Singh, Prop. Unitex Adventure, Nayagaon for issue of tourist permit for 'All routes in North, Middle & South Andaman Districts' as a new concept of introducing Limousine Service-Luxury Car concept in A&N Islands for improvement of high value tourism, it was decided to get the views of Police, Tribal Welfare and Tourism departments for further consideration of the issue by the S.T.A.
