10. Decision on the 44 application seeking NOC for new/change of stage carriage permits on various routes has been postponed till next meeting. In the meantime Secretary, STA will get the view of Police Department and STS and put up the cases to the Committee constituted for this purpose. It was decided to dissolve the existing Committee constituted by STA under the Chairmanship of Secretary (PBMC) for field study and scrutiny of application to form a committee comprising Assistant Director (Tpt.) from the Transport Department and an official of Police Department preferably Dy. Superintendent of Police (to be identified by Supdt. of Police (S.A)) to make field study of requirement of different routes and furnish their views and recommendation.

11. Show cause notices to all the owners of 298 No. commercial vehicles found parked at road sides/public places during the night (11.00 PM to 2.00 AM) of 8.4.2010 and 9.4.2010. In addition to individual show cause notices, it may be published in the Daily Telegrams also. The unserved show cause notices, if any, due to non-availability of persons on the given addresses or of any other reasons be handed over to Traffic Police for serving of the same. These matters alongwith the replies received be furnished in the next meeting for taking decision on further course of action.

- 12. Secretary (STA) requested for considering the point regarding mandatory requirement of parking shed as pre-condition for grant of NOC for commercial vehicle. The S.T.A. agreed to take it up in view of wide public concern expressed during public dealing at various levels. It was unanimously agreed that the condition of requiring a parking space cannot be dispensed with, but the STA may have no concern with the question whether such space is covered with a shed/roof or not, because the concern of STA is that commercial vehicles are not parked in public place/roads. As such decided as follows:
 - (a) That parking space requirement will continue to be a condition precedent for grant of NOC for commercial vehicle, without however insisting on such space being covered with a roof or a shed.
 - (b) The Secretary (STA) shall devise ways and means consistent with legal provisions to ensure that the same space is not being shown as parking space for more than a vehicle.
