महोदय,

Your kind attention is invited to the Additional Principal Chief Conservator of Forest, Van Sadan, Port Blair letter No. APCCF/FCA/197/72 dtd. 22nd June, 2016 and this office letter No. AN/D&W(40)/2016, dtd. 24/06/2016 addressed to Deputy Commissioner, Nicobar on the above cited subject.

In this context, it is intimated that the Honiph Rock Point in Katchal Island is a declare Tribal Reserve for Nicobar Tribe vide Gazette Notification No. ANPATR/3(1)/1 dtd. 2nd April 1957 of Andaman and Nicobar Island and requires clearance certificate under the provision of Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, for any Navigational operation by the Directorate.

It is therefore, requested to issue clearance certificate under the provision of ST& OTFD (Recognition of Forest Rights) Act, 2006 to this directorate for diversion of 0.14 ha of forest land in Katchal Island for Establishment of Lighted Beacon at Honiph Rock Point.

The Navigational Aids are urgently required at the Island for the safety and security of mariners and other security requirements of vessels plying form Port Blair towards Campbell Bay.

The matter may kindly be expedited and clearance conveyed to this office at the earliest so that this office can undertake this planned scheme of capital work 2016-17. As ministry of shipping is pressing hard for progress of work.
