

Secretary are the Chairman and Vice-Chairman of AAJVS which is the executive council with other Members. In addition to this there is an Advisory Committee.

Health - It is reported that during 1985-87, epidemic like dysentery occurred all over the Andaman & Nicobar Islands and took a heavy toll of Shompen. This could not be checked due to ~~lack~~^{of} their inaccessibility and lack of plan to meet such medical exigency. Then there is also the prevalence of malaria. Onge's have biological abnormalities affecting the reproduction. In the Master Plan (1991-2021) of Andaman & Nicobar Islands all matters relating to PTG's of this island has been covered. The plan programmes of each tribe has been separately given. However, the report should separately indicate the action plan on health, education and economic development sector. The Master Plan does not contain details of population figures of all the PTG's since 1961 census year. Further, the health and education status of PTG has not been given. The Action Plan must also in view of their experience and survey indicate any change which would improve the overall life styles of PTG's.

Gujarat

There are three identified PTG's viz., Kotwalias, Kathodis, Kolghas, Padhars and Siddis. the Major Sector wise break up of outlay during VIII plan period (1992-97) for each primitive group is as follows :-
