Note: The APWD was sanctioned funds for civil works at Strait Island during 2005-07 for Sl no: 1-3. But the buildings are yet to be handed over. An amount of Rs.168.00 lakks were deposited for c/o sea wall. This work was cancelled as per resolution made by the Executive Council during its meeting held during 10/8/2010. It was also resolved that APWD will utilize this amount for c/o retaining and toe wall for Jarawa Ward at PHC Baratang and refund the balance unspent amount, which the Chief Engineer APWD agreed too and confirmed that due to mistake they have asked for additional funds. Till date neither they have taken up the work at PHC Baratang nor refunded the amount. The buildings at Strait island is also not handed over.
