- 20. The State Government would be aware that the Special Central Assistance (SCA) is disbursed by the Central Government on the basis of a 3-factor formula:
  - (a) 50% on the basis of scheduled tribe population in the Tribal sub-plan area
  - (b) 30% on the basis of geographical area of the Tribal sub-Plan and
  - (c) 20% in inverse proportion to per capita Net State Domestic Product (NSDP) of the states.

Similarly, While allocating SCA to MADA Programme, Clusters and Dispersed Tribals (DTG) 70% of the total allocation is distributed according to Scheduled Tribes population in MADA area, Cluster and DTG and 30% in inverse proportion to per capita NSDP of the State/UT with weight age to tribal population within the pockets, clusters and DTG.

Thirdly, the SCA to Primitive Tribal Groups is distributed on the basis:

- (i) 40% of the amount on numerical size of the Primitive Tribal Communities.
- (ii) 30% according to population depending on different occupations, namely:

Food gathering or hunting

Shifting Cultivation,

Sedentary cultivation and

Other occupation with weight age recorded in the ratio of 5:3:3:1 respectively.

(iii) 15% according to number of Primitive Tribal Communities in the States/UTs.
