- 10. Annual Tribal Sub-Plan and Five Year Tribal Sub-Plan are formulated following the set of instruction issued by the Govt. of India from time to time. Plan documents finalized by the Department are scrutinized by the District Planning Committee which is chaired by the Adhyaksh of the Zilla Parishad (A & N Islands). Members of the Tribal council also forms a part of this District Planning Committee and the commendable suggestions put forth by these members are duly examined by the Department for incorporation in the Tribal Sub-Plan viewing the genuineness of the suggestions. Amended Tribal Sub-Plan documents are then approved by the District Planning Committee. Plan allocation is then allocated by the Govt. of India viewing the meeting of the Deputy Chairman (Planning Commission) with the Lt. Governor of this Union territory. The Department feels that the aforesaid procedure adopted shall be in force.
- 11. Educational requirements of the tribal habitations are worked based on the ground / field surveys. The survey report are then analyzed at the Directorate level. These are incorporated in the plan document while its finalization. Yes, it is a fact that the UT Annual TSP is finalized after discussion at the central level.
