KROF message No. 1-804/2004-TW(PF)/1373 Dated 12.8.2005 and subsequent signal reminder dated 20.9.2005 followed by a letter No. 1-804/2004-TW(PF)/1496 Dated 23.9.2005 regarding Utilization Certificate in respect of honorarium / grant-in-aid sectioned to the Tribal Councils during the last financial year 2004-05 (.). An amount of Rs. 16.182 lakhs was sanctioned as honorarium to the office bearers of the Tribal Councils, Car Nicobar, Nancowry, Kamorta, Chowra, Teresa, Katchal, Philobhabi and Kondul during the last financial year 2004-05 vide Admn.'s order No. 482 dated 23.11.2004, besides, a sum of Rs. 9.162 lakhs being arrears of honorarium to the office bearers in respect of Tribal Council, car Nicobar, Nancowry, katchal and Pillobhabi for the year 2003-04 vide this Admn's order No. 380 dated 25.8.2004(.). Similarly an amount of Rs. 31.22 lakhs was sanctioned as grant-in-aid to the Tribal Councils for creation of community facilities to be spent by D.C (N) on behalf of the Tribal Councils vide Admn.'s order No. 628 dated 14.3.2005 and order No. 676 dated 31.3.2005 (.). Para (.). The above amounts in the shape of Demand Drafts drawn in favour of D.C, Nicobar were remitted to him for utilization vide this office letters No. Accts-20/Cash-2003/TW/595 dated 17.9.2004, No. Accts-20/Cash-2003/TW/826 dated 13.12.2004 and Accts-20/Cash-2003/TW/1105 dated 21.4.2005(.). As per GFR, the Utilization Certificates in respect of honorarium / grant-in-aid sectioned to the Tribal Councils during the last financial year 2004-05 are required to Finance Department, A&N Administration for release of grants-in-aid for the current financial year 2005-06 (.). May kindly send the Utilization Certificates, both in respect of Honorarium and grant-in-aid separately to this office immediately (.).
