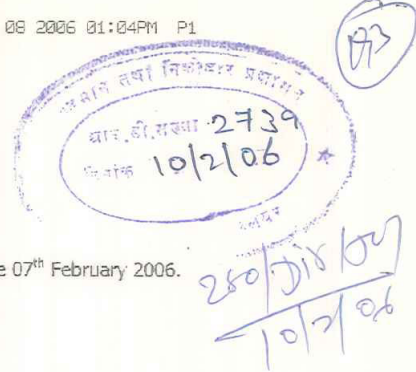

Sub: Proper accounting of Grant-in-aid and Honorariums and sanction of proposed schemes under ITDP to be routed through Assistant Commissioners, for their respective jurisdictions - Reg.

After Tsunami on 26/12/2004 implementation of works under ITDP have come to a standstill and less attention has been paid towards utilisation of Grant-in-aids released to different Tribal Councils. Expenditure Statements and utilisation certificates have not been received from the Tribal Councils from different Sub-division since Tsunami. As such progress report of the expenditure incurred and funds currently available with each Tribal Council may be furnished to this Office immediately. In future Quarterly Reports regarding expenditure incurred/utilisation certificates may be furnished to this Office.

It has come to notice that payment of honorarium for Tribal Captains for the previous years is still lying pending for one reason or the other. Report regarding disbursement of honorarium for the year 2003-04 and 2004-05 may also be submitted to this Office for settling the same.

The joint accounts operated by the Tribal Councils and respective ACs/SROs/BDOs may be closed and amount may be remitted back to Dy. Commissioner, Car Nicobar.

Proposals for the year 2005-06 for development activities to be taken up by different Tribal Councils, has yet not been submitted by the Tribal Councils. In this regard, respective Asstt. Commissioner of the Sub-division may personally liaise with the Tribal Council through the BDOs and obtain the same and thereafter after prioritizing a condensed list may be submitted to this Office for consideration and approval.

As already agreed to by APWD, works relating to creation of durable infrastructure may be endorsed to APWD on deposit basis.
