During the Tsunami the adjoining houses, paddy fields and the roads were submerged due to ingress of saline water. Hence, strengthening and raising of these bunds were necessitated to avoid further ingress of sea water. As per the Coastal Regulation Act 1991, in order to stop the ingress of Saline Water, Such structures can be constructed. Since these bunds were already existing only the raising/strengthening was taken up. (a copy of CRZ Regulation 1991 is enclosed As Annexure – A)
