NOTICE

Whereas vide Notification No. 243 dated 30.11.2007 a Buffer Zone area upto 5 KM radius around the Jarawa Tribal Reserve from Constance Bay in South Andaman to Lewis Inlet Bay in Middle Andaman has been declared by A & N Administration.

And Whereas, the Nilambur, Kauchengarh, Wreather's Creek, Rajargarh, Udaygarh, Kaushalya Nagar, Kadamtala and Santanu villages of Rangar Tehsil comes within the declared Buffer Zone. And any person other than a member of an Aboriginal Tribal is prohibited from entering the Buffer Zone for any commercial/tourism activities.

And Whereas, your Food Stall/Restaurants/Food establishment situated at Bahadurpur, Baniya Village falls within above notified Buffer Zone, which is liable to be closed down in compliance with the direction of the Hon'ble Supreme Court of India as per Order dated 03.12.2010.

Therefore, your Shop License No. 14574 under PFA Act is hereby stand cancelled with immediate effect and direct to closed down Food Stall/Restaurants/Food establishment. Failing which action as deemed fit shall be taken against you.
