The Administration alongwith A A J V S spent RS. 14.2287 CRORE only upto October 1998 under various sector for the 4 (four) Scheduled Tribes, i.e., THE NICOBARESE THE GREAT ANDAMANENESE, THE ONGES and THE SHOMPENS neglecting 2 (two) Scheduled Tribes namely THE JARWAS and the SENTINELESE as HOSTILE GROUPS in ANDAMAN AND NICOBAR ISLANDS and that Near About 2/3rd Fund, i.e.,

Rs. 28.85861 CRORE . remained for further utilization for the purpose upto the year end 31st March 99, the month instant.

Our findings on out and out investigations and inquiry for several years through different sources reveals that JARWAS became desperate to seek their victuals like fishes, Bi-Valve and Mollusean Shells which they call 'WAGH' in their language.

As usual for many a years JARWAS likely invasion and intrusion into Bengali and Ranchi Tribal areas at TIRUR, FERRERGUNJ and JIRKATANG to place to place through the ANDAMAN TRUNK ROAD (ATR) ^{including KARANTALA} has been turning to its occlusion at rampant begging for their FOOD-STUFFS unlike pilfering iron-materials time to time recently is the point of consideration as the PALPABLE AND VIABLE solution to their REHABILITATION without any delay as it is communicated that the Executive Secretary, A A J V S alongwith the ADMINISTRATION are making all out efforts for the WELFARE OF JARWAS for which the PUBLIC NEEDS must to keep them aloof of waiving any food items whenever JARWAS are spotted on their purpose.

Now the time has come to rehabilitate the JARWAS in their Main Area of R. K NALLAH in South Andaman enriching Sea-Creeks providing with their essential means of Survivalities and that the MOST NEGLECTED NOMADIC 4000 (four thousand) the Scheduled Tribe JARWAS POPULATION MUST NEEDS TO HAVE MODEL VILLAGE REHABILITATION GRANT OF RS. 25 (twenty five) CRORE IMMEDIATELY DURING THIS YEAR END ON THIS INSTANT MONTH OF MARCH 1998-99.

In the facts and circumstances as stated above we would urge upon the authorities concerned to take serious view on our grievances and to consider our DEMANDS as above-contented AS THE BEST REDRESS failing which after a month time we shall be constrained to resort Legitimate Agitational Path including PUBLIC INTEREST LITIGATION (PIL) before the Appropriate Authorities concerned.
