The Core Group consists of the following department to begin with:

4. Forest

6. Police

To recall the sentiments expressed by the C.S and Hon'ble L.G, it is imperative that the Jarawas continued to be confined inside the forests. Removing them from the forests would ultimately denude the forest which are so vital to these Islands viability. This is why a system of messing, sports, recreation and self-sufficient habitat inside the forests needs to be built.

On 16.3.99 (Tuesday) the following officials will depart from Port Blair to go to Tirur No.4 for this purpose. The assembly point would be at Tirur (Headquarter) at 9.00 am.
