ORDER

Whereas the Hon'ble Supreme Court of India has ordered on 03/12/2010 in Special Leave Appeal (Civil) no. 12125/2010 (A & N Administration -Vs- M/s. Barefoot Inn & Leisures Pvt. Ltd.) to close all commercial and tourists establishments falling within the Buffer zone in A & N Islands vide Buffer zone Notification no.234/2007/F.No.1-752/2007-TW dated 30<sup>th</sup> October 2007, which was communicated by the A & N Administration through the Assistant Commissioner (TW) vide letter no. 1-752/2009-TW(PF)/834 dated 07/12/2010 with the direction to comply with the order of the Hon'ble Apex Court.

And whereas the Deputy Commissioner (N&MA) vide note no. 41-19/DC (N&MA)/LS-BL/2007/2213 dt. 07/12/2010, authorised the Tehsildar, Rangat/DFO Baratang/MO I/c, CHC Rangat to take steps to close down all tourists establishments falling within the Buffer zone.

And whereas the Tehsildar, Rangat has issued notice to M/s. Dew Dale Resort, Sundergarh, Baratang vide notice f.no.9-23/TR/BZ/2010/863 dated 08/12/2010 directing the resort owner to close down the said resort in compliance of the above said order of the Hon'ble Apex Court.

And whereas the matter was further clarified to M/s. Dew Dale Resort, Sundergarh, Baratang that the resort falls within the Buffer zone and the resort owner was once again directed to close down the said resort vide letter no.9-23/TR/BZ/2011/04 dated 03/01/2011 by the Tehsildar, Rangat.

And whereas all the licences in Form "C" and Public Health Certificate of the resort have already been cancelled by the Medical Officer I/c, CHC, Rangat.

And whereas the Directorate of Tribal Welfare, A & N Administration has once again issued directions to the District Administration to close down all tourist establishments which falls within the Buffer zone vide letter no. 1-752/2009-TW/886 dated 24/12/2010.

And whereas the Tehsildar/Executive Magistrate, Rangat has issued an order no. 03 dated 14/01/2011 to Smti. Jessy John, Prop. M/s. Dew Dale Resort, Sundergarh, Baratang to close down the Dew Dale resort. Sunderaah with immediate effect otherwise it will be sealed.
