And Whereas, the Nilambur, Kanchangarh, Wrafter's Creek, Rajatgarh, Udaygarh, Kaushalya Nagar, Kadamtala and Santanu villages of Rangat Tehsil comes within the declared Buffer Zone. And any person other than a member of an Aboriginal Tribal is prohibited from entering the Buffer Zone for any commercial/tourism activities.

And Whereas, your Food Stall/Restaurants/Food establishment situated at ...including, Baratang Village falls within above notified Buffer Zone, which is liable to be closed down in compliance with the direction of the Hon'ble Supreme Court of India as per Order dated 03.12.2010.

Therefore, your Shop License No. ...M. S. ... under PFA Act is hereby stand cancelled with immediate effect and direct to closed down Food Stall/Restaurants/Food establishment. Failing which action as deemed fit shall be taken against you.
