In exercise of the power conferred by Sub Section 3A (1) of Section 3 of the Andaman and Nicobar Islands (Protection of Aboriginal Tribes), Regulation, 1956, read with amendment Regulation, 2012, the Lieutenant Governor, Andaman and Nicobar Islands is pleased to limit the 5 Km radius of Buffer Zone notified vide Notification 243/2007/F. No. 1-752/2007-TW dated 30<sup>th</sup> October, 2007 of the Directorate of Tribal Welfare, A&N Administration, by excluding from its purview all the revenue settlement villages falling within the said Buffer Zone except to the extent given below in respect of following portion namely: -

**South Andaman**

- 1) **Collinpur village-**  
**Southern boundary:** - An imaginary boundary starting from western coast of Collinpur village Latitude 11°41'11.64"N & Longitude 92°35'56.99"E proceeding towards east, joining Nallah at Survey No. 257 Latitude 11°41'10.40"N & Longitude 92°36'28.16"E  
**Eastern boundary** - The boundary from the Nallah proceedings towards North direction along with the eastern side of the Nallah joining at Village Road near survey No. 56 Temple Myo Latitude 11°41'30.21"N & Longitude 92°36'36.82"E.
- 2) **Temple Myo village**  
**Eastern boundary:** - The western side of the road starting from Survey No. 56 Latitude 11°41'30.21"N & Longitude 92°36'36.82"E and further proceeds alongwith the roads in North ward direction and join at village road near Survey No. 111 Herbartabad village Latitude 11°41'59.50"N & Longitude 92°36'52.21"E
- 3) **Herpartabad village**  
**Eastern Boundary:** - The western side of the road starting from Survey No. 111 Latitude 11°41'59.50"N & Longitude 92°36'52.21"E and further proceeds in North ward direction alongwith the road and join at Tirrur village road near survey No. 33 Latitude 11°42'50.19"N & Longitude 92°36'48.14"E.
- 4) **Tirrur Village**  
**Eastern Boundary:** - The western side of the road starting from Survey No. 33 Latitude 11°42'50.19"N & Longitude 92°36'48.14"E and further proceeds in North ward direction alongwith the road and ending at Tirrur Jarawa lookout post Latitude 11°44'1.33"N and Longitude 92°36'56.57"E

**Middle Andaman**

- 1) **Kadamtala Village**  
**Eastern Boundary:** - The western side of Bridle Path starting near survey No.736 Latitude 12°19'52.01"N & Longitude 92°46'26.56"E and proceeding alongwith the bridle path towards North direction and taking left turn towards west at survey no.354 Latitude 12°20'41.57"N & Longitude 92°46'19.06"E joining the village foot path at Survey No.225 Latitude 12°20'44.98"N & Longitude 92°46'8.68"E and proceeding alongwith the village road and turn towards North direction at Survey No.256 and proceed further up to 2 KM Latitude 12°20'47.25"N & Longitude 92°45'50.14"E.

The Lieutenant Governor is further pleased to order the exclusion of entire Baratang island and seaward side of the western and eastern boundary of Jarawa Reserve from the Buffer Zone.

The Notification shall remain enforce for a period of six months from the date of the publication of the notification in the Official Gazette or until further order whichever is early.
