Whereas vide letter no. 1-752/2009-TW/220 dated 08<sup>th</sup> April, 2010 received from the Assistant Commissioner (TW) has reported that a Buffer zone of an area upto 5 Km radius around the Jarawa Tribal reserve was notified by the A & N Administration vide notification no. 234/2007 F.No.1-752/2007-TW dated 30<sup>th</sup> October 2007.

Further, whereas the Assistant Commissioner (TW) vide letter no. 1-752/2009 TW (PF)/834 dated 07<sup>th</sup> December, 2010 has informed that the Hon'ble Supreme Court of India has passed order on 03.12.2010 in the matter declared Buffer zone in A & N Islands that all commercial and tourist establishments in the Buffer zone must be closed down and requested this office to take necessary action with regard to closure of bars, resorts, hotels & lodges in the Buffer zone.

Whereas the licence no. 41-32/DC (N&MA)/LS-ANIIDCO/10/581 Dated 01/4/2010 was issued to the General Manager, ANIDCO Ltd. to sell beer, wines, Foreign Liquor including IMFL by bottle from the shops situated at Kadamtala, Rangat, Billyground, Mayabunder and Diglipur.

Whereas Harinagar (Billyground) village comes under the Buffer Zone around Jarawa Tribal reserve as per the information available.

Therefore, the Deputy Commissioner, N & M Andaman District has directed to close the ANIIDCO wine shop situated at Billyground Bazar under Mayabunder Tehsil with immediate effect.

You are therefore required to take necessary action accordingly.
