

| 35. | Enhancement of quota of rice under APL category | According to MP, ANI, the A&N Administration has reduced scale of rations under APL category to 5 kg. of rice per adult per month since September 2008 due to short allocation of food grains. Scale of distribution of rice for APL category is 8 kg per head per month in Pondicherry & Lakshadweep and 16 kg per head per month in Mizoram. Scale of distribution of rice, therefore, is around 20-22 kg per month in Mizoram.
