Roads & Bridges

Shri. Raj Kumar Sharma, Member said that the ATR at Bakultala and Panchavati is in bad shape. It is to be repaired and proper drainage is to be constructed adjacent to ATR.

Smti. Minoti Biswas, Member stated that such problem exists at Chouldari ATR also. Further she added that only 1 KM road has been constructed in Hasmatabad to Wandoor road and the remaining road has not been constructed. As such the remaining road may be completed.

Shri. AR Marudhuvanan, Member told that the road from Marine gate to Dignabad School leading through Sisty Nagar is also in very dilapidated condition, which require some urgent repairs.

Smti. Anurupa Halder, Member had drawn the attention of the CE towards the road starting from Austin to Kishori Nagar via Mohanpur and requested to improve the same soon. She also requested to repair the road from Kalighat to Ram Nagar.

Shri. Sher Singh, Member told that it is noticed that no fund has been kept for improvement of roads. As such, attention is to be given for improvement road also. **The CE said that he is ready for improvement of roads provided DPC provides fund.**

Shri. Ramesh Ch. Ojha, Member said that the road from Tugapur Garage to Chainpur School is not in good condition. As such, no vehicle could ply to chainpur. Earlier vehicles use to come upto Chainpur School. A culvert is to be constructed opposite sub-centre, chainpur because the big log on the nallah was removed by the contractor to construct culvert but work not started. As such, the villagers are facing difficulty to cross the nallah. Likewise, the construction of 8 quarters at chainpur is left in plinth level by the contractor. It is to be expedited.

Smti. Reena Rani Roy, Member said that a bridge was to be constructed at Toratang nallah and Govindpur nallah and it also reflected in AP 2002-03 but the work has not started yet. It is also referred in 2002-03. The CE told it is under process. However, it is to be decided whether bally bridge or RCC Bridge is to be constructed there.

Meanwhile, the Hon'ble MP wanted to clarify as to when these works will be completed. The CE assured to complete within this financial year.

Shri. Ebrahim Ali Hussain, Member told that the road from Mus breakwater to Malacca is to be widened alongwith repairing. Near break water, soil erosion is taking part. In order to arrest the soil erosion, seawall is to be constructed near Mus Elpanam. The CE intimated in aggregate 1.35 KM seawall is under construction at Car Nicobar in 3 different locations. However, this work will also be taken up alongwith that work.

Shri. G. Paramasivam, Member said that c/o road from South Point to Machi line (Road from South Point to Laxmi Narayan Temple) was tendered but the contractor has not started the work. As such, he made complaint and this work was re-tendered but still this work has not commenced.
