After some time, I was again posted back to Campbell Bay as Assistant Commissioner. I took it as an opportunity to describe about the people and place of the Great Nicobar and Little Nicobar Island and policies associated with them from an administrative and academic angle out of my literary pursuit.

A brief description of the book.

This book has total 12 chapters .

"The Great Nicobar Island : India's Southern Fortune ", helps us understand how Andaman and Nicobar Islands, in general, and Great Nicobar Islands, in particular, can be a keystone of India's strategic and development trajectory. It also describes the fascinating collection of the exotic flora and fauna of the island and discusses the identity and tradition of the Nicobarese and Shompen tribes. I have accounted my journey to Indira Point, Navy Dera, Mount Thullier, Galathea, Makachua and Afra Bay and thus parts of the book read like a delightful travelogue.
